The following table provides monthly charge-off and delinquency statistics as of and for each of the thirteen months ended December 31, 2018. The increase in over-30 day loan delinquencies as a percentage of period-end loan receivables (the "30+ delinquency rate") at December 31, 2018 compared to the prior year period, is primarily due to the inclusion of the PayPal Credit program. Excluding the PayPal Credit program, the 30+ delinquency rate at December 31, 2018 was lower than December 31, 2017 by approximately 15 basis points.

The number of different charge-off cycle dates in each month varies based on such factors as the calendar and the timing of billing cycles. As a result, the amount of charged-off loan receivables can vary between monthly periods with no corresponding change in the performance of the portfolio. The following table sets forth the number of different charge-off cycle dates for our consumer credit card loan receivables, which represent greater than 95% of total period-end loan receivables at December 31, 2018, for the calendar months indicated.

⁽³⁾ Adjusted net charge-offs represent a non-GAAP financial measure. Adjusted net charge-offs as a % of average loan receivables, including held for sale, represent the Company's net charge-off rate for each month including the recovery adjustment' defined above. We believe the presentation of this measure is useful to investors as it represents a monthly measure which is more indicative of both our quarterly and annual net charge-off rates.
